ORGANIZATION INFORMATION AND RESPONSIBILITIES

Angels Among Us Pet Rescue agrees to provide a cat that has been tested for FeIV/FIV, vaccinated against rabies, FeIV, & FVRCP, dewormed, treated for fleas/ticks, spayed or neutered, and microchipped. Documentation of vet history will be provided to adopter and adopter will be informed of any known history of medical or behavioral issues. The organization agrees to refund the adoption fee or, at the discretion of the organization, provide another cat without charge if the adopted animal is returned within two weeks of the adoption date.

ADOPTER RESPONSIBILITIES

I, the adopter, agree to the following terms and provisions:

1. If this cat does not adapt to my home or I cannot keep the cat for any reason, I will contact Angels Among Us Pet Rescue to offer the animal back to the organization before relinquishing custody or possession of the animal to anyone else. Initials
2. From the date of this contract, I agree to assume full responsibility for the veterinary care for this cat, including an annual examination and routine vaccinations and tests, unless otherwise noted at the bottom of this document. I will keep the cat free of pests and parasites, including fleas & ticks.
3. The cat will be kept inside 100 percent of the time, except when being transported. When transport occurs, the cat shall be secured inside a pet carrier. Initials
4. I will not declaw this cat and understand that doing so will entitle Angels Among Us Pet Rescue to reclaim the cat. Initials
5. I will keep the cat's microchip registration up to date and will notify the microchip company of any change of contact information.
6. I agree to provide notification to Angels Among Us Pet Rescue within 14 days of any change of address, phone number or any circumstances that will affect the cat.
7. I agree to not abuse or neglect the cat and under no circumstances will physically punish the cat. Rather, I will consult with Angels Among Us Pet Rescue, a veterinarian, or trainer about the appropriate ways to deal with specific behavior problems.
8. I consent to the examination of this cat by Angels Among Us Pet Rescue at any time and acknowledge that Angels Among Us Pet Rescue has the right to reclaim this cat at any time for failure to comply with the terms of this contract or for any misrepresentation of fact made on the adoption application or in this contract.
9. If for any reason this cat is not fully vaccinated prior to the execution of this contract, I agree to take the cat to an AAU approved vet when contacted that the vaccines are due at no cost to me. I acknowledge that until this has been accomplished, my adoption of this cat is not complete and that Angels Among Us Pet Rescue has the right to and will reclaim the cat if the vaccines are not done. 10. I understand that the adoption fee is non-refundable, except when the cat is returned within two weeks of the adoption date.
11. I understand that this is a legal and binding contract and by my signature agree to all of the terms herein.
12. I confirm that all information given in this contract is correct and accurate. I also understand that once the contract is signed and I have taken possession of the animal, I will be solely responsible for any actions of this animal and I agree to hold harmless Angels Among Us Pet Rescue and its representatives from any liabilities, injuries or loss caused by this animal or any causes of actions, claims, suits or demands that arise from such injury, damages or losses. In the event the terms of this contract are breached, I, as the Guardian of this pet, shall owe Angels Among Us Pet Rescue the sum of \$1000 for liquidated damages, and will be responsible for all attorneys fees and court costs involved, as well as returning the animal to Angels Among Us Pet Rescue.
