**SUBLETTING OF SPACE** – No Vendor shall assign or sublet the whole or part of the space allotted, or booth therein, to any programs or services other than those specified in the contract for booth space. Only one company per booth is permitted.

**CARE AND STAFFING OF BOOTHS** – The Vendor will be responsible for its own loading, unloading, booth set up, and clean up of its area. Volunteers will assist in setting up and taking down the canopies and tables. Vendor can bring vehicles into the event area to unload merchandise, but on event day the Vendor agrees to have this task completed and the vehicles removed by **6:30AM**. The Vendor agrees that after **6:30AM** all booth materials must be walked into the park. The Vendor agrees to have its booth staffed and open for business by **6:30AM** on event day. Vendor **MUST** remain at the booth until **11:00AM** on event day.
